

## Complimentary Green Fees for Golf in Singapore

### Privileges

With compliments of Visa, perfect your swing with rounds of golf at the participating golf club where Primary Visa Infinite cardholders ("Cardholder") enjoy weekday complimentary green fees all year round (the "Offer"). Terms and conditions apply.

### Validity

1 January 2026 – 30 June 2026

### Terms and Conditions

#### I. General Conditions

1. Offer is valid from 1 January 2026 to 30 June 2026 and subject to change and tee- time availability.
2. Cardholders must book the Offer with their valid Visa Infinite cards issued in Singapore.
3. The Offer is fully subsidized by Visa and is not a direct offer from the Club.
4. A minimum of 1 paying guest per Cardholder is required. For example, if there are 2 Cardholders playing in the same flight using the Offer, there must be a minimum of 2 paying guests in the same flight.
5. Offer is valid on **weekdays excluding public holidays**.
6. Bookings are capped at a maximum of 4 per cardholder for the year. Cardholders acknowledge that there are a limited number of complimentary green fees per month and bookings will be fulfilled on a first-come, first-served basis. Once the monthly limit is reached, no further bookings will be accepted for the month.
7. At all times, only one active golf booking per Cardholder is allowed. For the avoidance of doubt, Cardholder may only place a new golf booking after the completion of an active booking and each cardholder may make a maximum of 1 booking a month.

#### II. Reservations

1. The Offer is valid for use only where bookings are made directly via the following booking website [https://promotions.visa.com/campaign/sentosa\\_golf/](https://promotions.visa.com/campaign/sentosa_golf/)
2. Golf bookings open on the first of every month and processed on a first-come-first-serve basis.
3. There are a limited number of complimentary rounds each month, and once the monthly limit is reached, no further bookings will be accepted.
4. Bookings must be made at least 5 working days in advance for Sentosa Golf Club and at least 3 working days in advance for Tanah Merah Country Club. (Date of booking is not counted in the 5 working days).

5. Cardholder cannot book a tee time more than 14 calendar days in advance. Note that intended tee-off date is not counted.
6. Acceptance of all golf bookings, pairings and changes to tee times will be at the discretion of the Club and are subject to availability. Cardholders will not be granted access rights to the Club without prior bookings through Visa in accordance with these Terms and Conditions.
7. A status update on the golf booking request will be sent to Cardholders within 2 working days.
8. Cardholders may not book the next golf game until the current booked game has been played.
9. Rates are subject to change without notice.
10. Cardholders and guests must have valid handicap and golf insurance policy. The Club may require golfers to produce their handicap card upon registration.
11. A golf club member cannot make a booking directly at the Club and transfer the confirmed tee-time over to the Cardholder.

### **III. Fees and Charges**

1. All payments for Cardholders and guest(s) must be charged to their Visa Infinite card upon booking.
2. Cardholders are responsible for buggy, caddie, turf mate, locker fee, insurance, taxes and all other ancillary and miscellaneous charges for themselves and their guests (“Other Charges”) at normal published rates where applicable, subject to the Club’s Terms and Conditions, and the Other Charges will be charged to the Visa Infinite card used to book the Offer.

### **IV. Cancellation, Amendment and Charges**

1. Cancellations and amendments must be made via email at (seagolf@apexlynx.net) and will not be accepted by the participating clubs if contacted directly.
2. Cancellations and amendments must be made at least 3 working days in advance prior to the tee-off date.
3. Full published golf rates<sup>#</sup> stipulated by the Club will be levied and payable by the Cardholder for any short notice cancellations, late arrivals or no-show and charged to the Visa Infinite card used to make the booking.
4. Cancellation fee will be charged to the Visa Infinite credit card used to make the booking.
5. In the event of a “no show” during any month, the Cardholder will not be allowed to make any booking for that month and the subsequent month.
6. In the event of any refusal to pay cancellation charges, the Cardholder will not be allowed to make any further bookings under the Offer.
7. An administrative fee of USD10 plus applicable GST or as applicable will be charged for all amendments made to confirmed bookings.
8. There will be no rain check due to bad weather conditions.

Note:

*#Published golf rates includes green fee, buggy fee and/or caddie fee and golf insurance where it is deemed as “compulsory golf fee” by the Club. Schedule of golf fees as applicable to VI Cardholders and guests are subject to change as per decision of the Club.*

## **V. Other Terms**

1. The Club will not entertain any correspondence / enquiries and / or attempts for bookings directly from the Cardholder. The Offer cannot be used by the Cardholders or their guests in conjunction with any other promotional golf offers.
2. Visa reserves the right to replace the Club under this Offer, without prior notice to the Cardholders.
3. Golfing privileges offered to the Cardholders are not to be regarded as a membership to the Club.
4. The Offer to the Cardholders is valid for golf course access only (not driving range access). Cardholders and/ or their guests will not have access to other members' only facilities at the Club.
5. To the fullest extent permissible by law, each participating Cardholder releases Visa from any claim, loss, damage, cost or expense (including any claim for legal expenses) sustained or incurred by him/her in connection with their participation or attempted participation in the Offer.
6. Visa does not make any representation or warranty, express or implied, in relation to the services or facilities provided by the Club and to the maximum extent permitted by law shall not have any liability for any deficiency, delay or imperfection in such services or facilities for any loss or damage that may be suffered by any person, or for any personal injury to any person directly or indirectly by use or non-use of the services or facilities provided by the Club and Visa will not entertain any claim from any Cardholder in connection with the participation or lack thereof in the Offer.
7. Cardholder(s) and their guest(s) may be denied services in the event that the said Cardholder(s) and/or their guest(s) cause an infringement of any rules and regulations at the Club and / or indulge in unacceptable code of conduct and / or infringe the Club's etiquette resulting in a decision being taken by the concerned Club to deny future access to such defaulting said Cardholder(s) and/ or guest(s).
8. This is an Offer exclusively provided to eligible Cardholders. Visa reserves the right to deny and permanently withdraw the benefits of the Offer to any person found to act dishonestly or fraudulently in relation to the Offer or its privileges or be in breach of any of the Terms and Conditions of the Offer.

## **VI. Governing Law**

The Terms and Conditions will be governed by and construed in accordance with the laws of Singapore, without regard to conflict of law principles. Each Party consents to the exclusive jurisdiction and venue of the Singapore courts in connection with any dispute or controversy arising out of or in connection with this Agreement or its subject matter.

## **VII. No Rights of Third Parties**

A person who is not a party to this Terms and Conditions has no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any term under this Terms and Conditions.
